- i. Wedding Policy at Our Savior's: A proposed wedding policy was reviewed. It is important to note that the ELCA leaves such decisions to be discerned in each respective congregation. After consideration of synod resources, consultation with other area Lutheran (ELCA) congregations, discussion and prayer the council moved to consider the motion below. The Soul Script (vision, mission, and values) approved by the congregation was used as a point of reference; "Our Savior's is a vibrant, Spirit led community that welcomes all ages and invites people from all walks of life to follow Jesus". The proposed wedding policy statement is:

In light of the fact that same-gender marriage is legal in all 50 states, consistent with our understanding of the policy recommended by the ELCA's 2009 Social Statement on human sexuality, and understanding the fact that we, as Our Savior's Lutheran Church members, may not be of one mind on the matter, but are one in Christ and centered in grace, Our Savior's Lutheran Church supports granting our pastors the freedom to follow their bound consciences and pastoral discretion in responding to requests to perform same-gender marriage and to offer pastoral ministry either off-site or at Our Savior's Lutheran Church.

Becky Cusey made a motion to approve. Nate Heinrich seconded. Motion passed.

Discussion on the wording of the policy was held. Nate Heinrich made a motion to amend the approved policy statement by removing "and pastoral discretion". Pete Kim seconded. **Motion passed.** The amended wedding policy is as follows:

In light of the fact that same-gender marriage is legal in all 50 states, consistent with our understanding of the policy recommended by the ELCA's 2009 Social Statement on human sexuality, and understanding the fact that we, as Our Savior's Lutheran Church members, may not be of one mind on the matter, but are one in Christ and centered in grace, Our Savior's Lutheran Church supports granting our pastors the freedom to follow their bound consciences and pastoral discretion in responding to requests to perform same-gender marriage and to offer pastoral ministry either off-site or at Our Savior's Lutheran Church.

Nate Heinrich requested a roll call vote on approval of the wedding policy. Grant Invie seconded. The roll call was made as follows: Grant Invie – yes; Nate Heinrich – yes; DeAnn Smith – yes; Pete Kim – yes; Becky Cusey - yes; Dan Bentley – yes; Cathi Chial – yes; Kathe

Eldred – yes. Two members, Connie Jarrett and Traci Goble were absent. Both responded by email vote on Wednesday, January 18, with "Yes" votes. The **Motion passed** as amended and passed unanimously.

**j.** Cathi Chial shared her ideas about creating a parish nursing program at Our Savior's. Cathi will gather information and report at a later date.
